

PUBLIC NOTICE


Public notice is hereby given that the Council of the Rural Municipality of Corman Park No. 344 intends to adopt a bylaw under The Planning and Development Act, 2007 to amend Bylaw No. 09/94, known as the R.M. of Corman Park Zoning Bylaw. INTENT

- a) Proposed Bylaw No. 37/18 will provide amendments to: Amend the Table of Contents by correcting the i)
 - numbering of the Schedules accordingly. Amend Section 5, Schedule O - RWM - Regional ii)
 - Waste Management District by separating subsection 2.1.b) into two uses and renumbering the subsections. iii) Amend Section 5, Schedule O - RWM - Regional
 - Waste Management District by adding "Commercial Composting Operation" into section 2.2 as a discretionary use and renumbering all the subsections alphabetically.
 - iv) Correct the term "Use Building Material Outlet" to "Used Building Materials Retail Outlet" in Schedule O, Section 2.2 g) and Section 6.69.
- v) Amend Section 6.221 by adding "Commercial Composting Operation" to the definition of "Waste Management and Remediation Industry." Proposed Bylaw No. 38/18 will rezone from Agricultural b) District (AG) to Agricultural Residential 1 District (AR1) the lands described below. Proposed Bylaw No. 38/18 will allow for the creation of title for one existing yard site
- and allow for the creation of one new residential yard site. Proposed Bylaw No. 39/18 will rezone from Agricultural District (AG) to Agricultural Residential 1 District (AR1) the lands described below. Proposed Bylaw No. 39/18 will allow for the creation of two new residential yard
- sites. AFFECTED LANDS The affected lands are all lands contained within the a) R.M. of Corman Park, with the exception of the area

- included in the Corman Park-Saskatoon Planning District (Bylaw 37/18). The affected lands are all that portion of SE 18-39-4-W3 b)
- shown shaded on Map 1 (Bylaw 38/18). c) The affected lands are all that portion of NW 23-39-4-W3
- shown shaded on Map 2 (Bylaw 39/18).
