BYLAW 07/22

A BYLAW TO PROVIDE FOR THE CLOSING AND SELLING OF A MUNICIPAL ROAD

The Council of The Rural Municipality of Corman Park No. 344 in the Province of Saskatchewan enacts as follows:

Subject to the consent of the Minister of Highways, the Rural Municipality of Corman Park No. 344, agrees to close and transfer the municipal road or street described as:

All that portion of original road allowance West of the NW 31-35-5-W3 and shown lying within the bold dashed line on a plan of proposed subdivision prepared by Brad Luey, S.L.S., Webb Surveys, dated December 7, 2021 and hereto attached.

As shown within the bold dashed lines, on the updated Plan of Proposed Subdivision, dated January 19, 2022, and marked as attachment 'A' and forming part of this Bylaw.



